## 3. PROFILE OF SKILLS AND COMPETENCES

**General competences:**

- take responsibility for completion of tasks in work or study;
- adapt own behaviour to circumstances in solving problems;
- be familiar with various methods of learning, use sources of information well, show functional literacy;
- understand assignments or identify the cores of problems, exert variable solutions, work both independently and within a team;
- communicate in one foreign language at the level of at least A2+ of the Common European Framework of Reference for Languages;
- cope with changing socio-economic conditions, be financially literate;
- be aware of the labour market mechanisms, and of the employee-employer relationships, act on career decisions responsibly, understand the significance of lifelong learning;
- use basic mathematics and the basic principles of physics and chemistry when needed in daily situations;
- work with the means of information and communication technologies, exploit adequate sources of information, handle information effectively;
- act in an environmentally-conscious manner and in compliance with strategies for sustainability;
- support values of local, national, European and world cultures, recognize the value of life;
- exert fundamentals of health protection, occupational safety, and fire prevention and safety;
- exert norms and prescriptions in the field.

**Vocational competences:**

- read and prepare design and technological documentation for simple joinery products or their parts;
- select and use suitable manners of preparation, treatment, and storage of materials;
- select and use optimal materials, hand tools, machinery and technological processes in the production of a given product;
- adjust and maintain manual tools and machinery, set their optimal parameters, and ensure the functionality of production equipment;
- create custom-made or mass produced furniture, internal furnishings, and joinery;
- suitably package, store, and ship finished products;
- inspect the quality and ensure the aesthetic appearance of products;
- use simple computer applications;
- process wood waste in an environmentally friendly manner.

**Specific vocational competence for furniture makers:**

- perform simple repairs and renovate furniture.

**Specific vocational competence for joinery:**

- install joinery products in buildings.

**Specific vocational competence for wood construction:**

- carry out professional joinery work in the creation of wood constructions;
- complete and install wood constructions.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE



Graduates are employed as joiners in the area of woodworking production, especially as furniture makers and joiners. After acquiring the necessary practical experience in the field, they are soon prepared to run their own businesses in the given area.

Examples of possible job positions include: furniture maker, joiner, furniture installer.
